

The Rotary Club of Chicago is the founding Club of the world's premier international business and service organization.

Rotary members are business and professional leaders who volunteer their expertise, compassion and power to improve communities at home in Chicago as well as in communities around the world.

The Rotary Club of Chicago, known as ROTARY/One, was founded in 1905 in Chicago by four businessmen for professional synergy and friendship. They soon began to pull their collective talents together and started solving local community problems. Within 10 years, Rotary was on the east and west coasts and in Canada. Today there are over 33,000 clubs and 1.3 million members around the world.

## Rotary impacts the Chicago Community and beyond!

ROTARY/One's signature project, Job1, provides job skills training and summer internships to qualified Chicago Public High School students, giving them valuable work experience and contacts that can positively impact their future. Job1 has provided over 250 students with a summer internship since its inception in 2005.

ROTARY/One has presented over 10,000 dictionaries to CPS third graders.

Rotary builds peace and understanding through education and dialogue including hosting a Peace Summit held in October 2012, bringing together Chicago community leaders, including Toni Preckwinkle, to talk about issues concerning gun violence, and the communication and education gaps involved.

International projects involving clean water, bicycles and school materials in India; resources for people to start businesses in Togo, Africa; shelters for people in Haiti – through our many international partner Clubs, ROTARY/One is a meaningful participant in contributing to the economic, education, health and well being of people in our World community.



## VICTORIA ANNE BRANDER, M.D.

## Operation Walk Chicago

Victoria Brander MD is a board certified Physical Medicine and Rehabilitation specialist. She serves as Associate Professor of Physical Medicine and Rehabilitation at Northwestern University' and a member of the NorthShore University Health System.

Among a long list of awards and recognition, Dr. Brander was named by her Department the Research Mentor of the Year



in 2000. Dr. Brander was also named by Chicago Magazine as one of Chicago's top physicians. She is an award-winning researcher, including receiving the prestigious Knee Society award twice, for her work in pain, depression and joint replacement outcomes. She has authored numerous publications on the topics of arthritis and joint reconstruction is a regular contributor

to TV and print media.

With David Stulberg MD, Dr Brander co-founded and directs Operation Walk Chicago, a medical not for profit service organization that performs free hip and knee replacement surgeries for underserved patients in Chicago and throughout the world. Dr. Brander has led Operation Walk Chicago, in China, Ecuador, India, Nepal and Vietnam. In recognition of her humanitarian service, Dr Brander was presented with the "Unsung Heroes of Compassion" award by His Holiness The Dalai Lama.



## PATRICIA JAHN

## Chicago502.org

Patricia Jahn was fortunate to be a stay at home mom which gave her an opportunity to participate in community activities. Over the years these included a gambit of organizations such as Boy Scouts of America, League of Women Voters, and a myriad of charitable, school, and social groups; almost all of which she served in a leadership capacity. Patricia has been involved with the Union League Club Civics & Art Foundation, and the Chicago Engineers' Foundation as well as the Chicago502.org.



Chicago 502.org is a phenomenal organization whose sole purpose is to provide support for the men and women in the 502nd Brigade of the 101st Airborne. Patricia and her husband, Martin, have both served on the board and were instrumental in initiating the Wounded Soldiers' Fund. In conjunction with that, Patricia began a program in 2006 to

provide quilts for the men and women of the 502nd who were injured in battle or for the families of fallen soldiers. To date they have made more than 100 quilts for the soldiers. Several years ago a small group of ladies who belong to the Centennial Quilt Guild of LaGrange adopted Patricia's project and now even more quilts are being made. She also collected quilts from other groups and thus more than 250 quilts have been delivered to the 502nd. Patricia says, "With each quilt made, I pray that it will not be needed; praying that peace will come to our world and there will no longer be any wounded or fallen soldiers."



## LISA MADIGAN

## Illinois Attorney General

In November 2002, Attorney General Madigan became the first woman elected to serve as the Illinois Attorney General. In 2010, she was elected to her third term as Attorney General and now is the senior-most female Attorney General in the country. Madigan has demonstrated principled leadership, putting policy before politics and focusing her work as the state's top legal advocate on protecting the people and communities of Illinois. Among many other initiatives including consumer protection, protecting older citizens and safeguarding our environment, Madigan has dedicated the energy and resources of her office to protecting children and women from the

dangers of sexual predators and established herself as a leader in the public's fight for open and accessible government.

Madigan is the first Illinois Attorney General in over 25 years to personally argue a case before the U.S. Supreme Court (*Illinois v. Caballes*) in which the Court upheld the ability of law enforcement to detect the presence of illegal drugs during traffic stops. In the national arena, Madigan is a respected advocate, regularly testifying before Congress and federal commissions charged with strengthening consumer financial protections.

Madigan's firm belief that one person can make a difference is what led her into a career in public service and drives her work as the state's chief legal officer. Madigan received the John F. Kennedy New Frontier Award in 2005 from Caroline Kennedy Schlossberg, who in presenting the award, recognized Attorney General Madigan as "an inspiration to all young Americans who share my father's belief that one person can make a difference and everyone should try." In 2006, Madigan received an Aspen Institute Rodel Fellowship, which recognizes the nation's most outstanding young political leaders and is focused on the ethics and responsibilities of public leadership.
